### Sewer - Outside Corporate Limits

Customers not connected to City water system	\$46.98 minimum

# ELECTRIC RATE SCHEDULES

## Residential Service - Schedule RS

**Availability:**

Available only to residential customers in residences, condominiums, mobile homes, or individually-metered apartments which provide independent and permanent facilities complete for living, eating, cooking and sanitation.

**Monthly Rate:**

Basic facilities charge:	\$12.17
Energy charge:	
First 500 kWh, per kWh	\$0.10862
All above 500 kWh, per kWh	\$0.11518

## Residential Service - Schedule RE

**Availability:**

Same as Schedule RS with the following addition, all energy required for all water heating, cooking, clothes drying, and environmental space conditioning must be supplied electrically, and all electric energy used in such dwelling must be recorded through a single meter.

**Monthly Rate:**

Basic facilities charge:	\$12.17

First 500 kWh, per kWh	\$0.10805
All above 500 kWh, per kWh	\$0.10604

## Small General Service - Schedule SGS

**Availability:**

Available to the non-residential customer with a monthly demand of 30 kW or less, until the customer's monthly demand exceeds 30 kW in any three months of the preceding twelve months.

## Medium General Service - Schedule MGS

**Availability:**

Available to the non-residential customer with a monthly demand greater than 30 kW but less than 200 kW, until the customer's monthly demand exceeds 200 kW in any three months of the preceding twelve months.

## Large General Service - Schedule LGS

**Availability:**

Available to the non-residential customer with a monthly demand greater than 200 kW until the customer's monthly demand falls below 200 kW in any three months of the preceding twelve months.

## Traffic Signal Service - Schedule TS

Available to municipalities in which the City owns and operates the electric distribution system, and to County, State, and Federal Authorities, in areas served by the City, for the energy requirements of traffic and safety signal systems.

**Monthly Rate:**

Basic facilities charge:	\$5.11
Energy charge:	
First 50 kWh, per kWh	\$0.21698
All above 50 kWh, per kWh	\$0.10127
Minimum Bill per month	\$5.11

## Outdoor Lighting Service - Schedule OL

**Availability:** Available to the individual customer for lighting of private outdoor areas at locations on the City's distribution system. Service under this Schedule may be withheld or discontinued at the option of the City.
